- Please provide a Safety Data Sheet (SDS) for any substances the product has been exposed to. Ideally this should be in English.
- Please be aware that the end user is responsible for decontaminating the goods before return. Additional cleaning charges will apply if in our judgement the product is returned unsuitable to work on.
- Please **do not** send anything without a RMA or RGA number.
- The Decontamination Declaration **must** be signed by the **end user** even if stated unused.
- When you have completed this form and returned it to us, we will acknowledge acceptance by sending you a RMA or RGA number and the delivery address.
- The goods must be suitably packed and clearly marked with the RMA or RGA number. We are not responsible for any damage during transit to us.
- Please complete the form clearly
- Pumps **should not** be returned with tubing or tube element still loaded within the pump head. If tubing or tube elements are being returned for investigation purposes a separate Decontamination Declaration must be filled out.
- Qdos pump drives **must not** be returned with a ReNu pump head. Any ReNu pump heads received will **not** be returned.

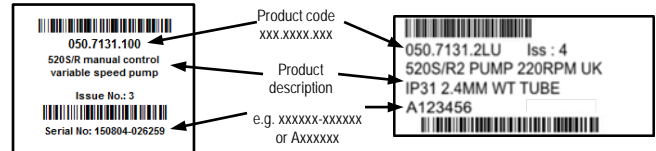
